

Terms and Conditions for Laundry Services

Payments Terms: Invoices are to be settled within 7 days of receipt, unless a prior arrangement has been

made. A 5% late payment fee will be applied to overdue invoices. We reserve the right to not

collect or deliver any items until payment has been received.

Cancellations: Should you need to cancel your laundry service, we kindly ask for a notice of at least 7

days prior to the scheduled service date. Cancellations within the 7-day period leading up to the service will incur a 50% charge, and cancellations within 7 days of the service date will result in the full payment being applied. You're understanding and cooperation in this

matter are highly valued.

If you are in a property managed contract, the cancellation policy will be in line with your

booking provider and will be within your contract.

Photography Permissions: To showcase the excellence of our laundry services, we occasionally capture images of our

work. With your consent, these images may be used at our discretion on our website and

social media platforms.

Key Arrangements: We request either the provision of a key safe number or, alternatively, a set of keys to be

securely held by Pure Sage Holidays.

Storage Arrangements: Complimentary laundry bags will be provided by Pure Sage Holidays for your convenience.

If a change in drop-off or collection times is necessary, we kindly request customers to provide a secure waterproof box for outside storage. This ensures the continued safety and

protection of your items.

Turnaround Timings: Your laundry service will be completed with the utmost care and efficiency, typically being

returned between the hours of 10 am and 4 pm. If you have specific timing preferences, please feel free to discuss and finalise those details in advance. While we strive for a minimum turnaround of 3 days, it's important to note that during busy peak seasons, the completion time may extend slightly up to 7 days. Rest assured, we are dedicated to maintaining the quality of our service, and we appreciate your understanding and patience during these peak periods. Any deviations from this schedule will be communicated to the

customer in a timely manner.

Bank Holidays: For national bank holidays (Inc Sunday & Mondays), an additional charge of £30.00 will be

invoiced. Please note that we are closed on Christmas Day, Boxing Day, New Year's Day,

and Easter Sunday.

Sunday Turnarounds / collections: Please note we are closed on Sundays.

Pets and Damages: In cases of excessive pet hair or noticeable mess/damage, an additional charge will be

applied. Please note that no responsibility will be taken for damages, excessive marks on

bedding, or towels.

Stain Removal: While all reasonable care is taken, we cannot guarantee that all stains on items being

washed will be removed, or that an item will not shrink or remain colour fast. Stained items

are cleaned at owners' risk.

normal cycle, and dried using heat in a tumble dryer. We cannot be held responsible for any

damage to items that are not suitable for this standard laundering purpose.
